CONFIDENTIALITY, NON-DISCLOSURE AND NON-CIRCUMVENTION AGREEMENT

This confidentiality, non-disclosure and non-circumvention agreement (this "agreement") made this ____ day of _____, 20____ by and between _____, [hereinafter "Employ"] and **GODZONE MINISTRY, INC.** [hereinafter "Production Company"], its principals, and affiliates (including, without limitation, STUART MILLER) is made here and today to protect and secure the creative rights and ownership of **"HOMELESS HENRY TTT"** [hereinafter "Film Project"].

Confidentiality All information, documents, photos, video, materials, quotes or interviews disclosed or allowed by Production Company to Employ that relates or refers, directly or indirectly, to the Film Project, shall be deemed confidential including all documents, photos, materials, quotes or interviews, generated by Film Company, Employ or any source which contain, comment upon, or relate in any way to the Film Project, and any samples of the Film Project received by Employ together with any information derived there from that are not specifically released to Employ with written authorization from **Stuart Miller**. Employ understands and agrees that the disclosure of the Film Project's information, documents, photos, materials, quotes or interviews by the Employ to anyone other than what is stated in this agreement could irreparably damage Production Company. As consideration and in return for the disclosure of this Film Project, Employ shall keep secret and hold in confidence all such information, documents, photos, materials, quotes or interviews concerning the Film Project and treat the Film Project as if it were Employ's own proprietary property by not disclosing it to any person or entity other than where written agreement is made. Employ agrees to exercise the same degree of care to keep the Film Project secret and confidential as it employs to preserve and safeguard its own materials. Except for the sole purpose stated in Paragraph 2 above, Employ agrees that it is prohibited from disclosing, disseminating, sending, delivering, conveying (in any form or through any media), sharing, or discussing (either verbally or in writing) any Confidential Information, or any portion thereof, with any person or entity which is not an employee, agent or officer of Employ, or an investor known to the Employ.

Ownership of the Film Project Employ acknowledges and agrees that Production Company owns all rights to the Film Project and all Confidential Information and intellectual property relating to the Film Project. Employ agrees that Production Company might suffer irreparable harm as a result of breaching this Agreement and that monetary damages may be inadequate to compensate Production Company for such breach. As such Employ agrees that Production Company in addition to and not in lieu of other rights and remedies, shall be entitled to temporary or permanent injunctive relief in order to prevent further losses.

Successors and Assigns. This Agreement shall be binding upon and shall inure to the benefit of the parties and their respective legal representatives, successors, and assigns.

Entire Agreement. This Agreement sets forth the entire agreement between the parties and may not be amended or modified, except by a writing signed by all of the parties.

Attorney's Fees. In the event of litigation between the parties in connection with this Agreement, the unsuccessful party or parties to such litigation will pay to the successful party therein all costs and expenses, including reasonable attorneys' fees and costs incurred therein by such successful party, which costs and expenses shall be included as a part of any judgement rendered in such action, in addition to any other relief to which the successful party may be entitled.

Governing Law. This Agreement will be governed by and construed in accordance with the laws of the State of Texas, applicable to contracts entered into and performed entirely within the State of Texas. Any action brought on any matter hereunder may be instituted and maintained in a state or federal court of general jurisdiction in Marion County, Texas, and each party hereby waives any objection that party may have to either the jurisdiction or venue of such court. Employ hereby irrevocably appoints Production Company as Employ's agent for service of process for litigation hereunder, and Production Company shall forward a copy of any such process to employ by fax, e-mail or regular mail.

Severability. In the event any provision of this Agreement shall be held invalid or unenforceable by any court of competent jurisdiction, such holding shall not affect the validity of the remaining provisions hereof.

Counterparts. This Agreement may be executed in two (2) or more counterparts, each of which shall be deemed an original without production of the others.
